

#### Warranty Description

(2) If there is a failure caused by non-man-made reasons, the user can have free maintenance at the designated maintenance point with the warranty card and the purchase certificate during the warranty period.

The following are not covered by warranty services:

(1) The product exceeds the warranty period;

(2) No valid invoice, and unable to prove that the purchased product is within the warranty period;

(3) The model of warranty card does not match the product model;

(4) No warranty card or the warranty card has been altered;

(5) Damage caused by human factors;

(6) Unauthorized maintenance, violent operation, disassembly, modification, extrusion, liquid infusion and corrosion;

(7) Damage caused by force majeure such as floods, fires, lightning strikes, etc.

Huntkey will calculate proper maintenance costs based on parts and labor costs if users need repair services in the case of warranty services failure.

We will give repair services after obtaining the user's consent and pay the fee.
